It has come to the notice of the Government that the Executive Engineers of the ESCOMS have entered into an Agreement for establishment of a large number of solar roof top projects in your district in violation of the Regulations and Policy of Government. Some of the violations for which the Dy. Commissioners may take action on are —

1) Solar Roof Top agreements have been entered into for buildings which have no approvals like Plan sanction from the Competent Authority:

2) No conversion of land under Sec. 95 of the Karnataka Land Revenue Act has

been approved by the Dy. Commissioners;

3) A large number of companies have entered into agreement for construction of solar roof top showing agricultural land for which they are not owners. They have also not applied under Sec. 109 of the Land Reforms Act for permission to purchase;

4) Leasing of agricultural land for this purpose in violation of the provisions of

Land Reforms Act.

5) Buildings are being constructed without taking approvals under 'aws from Deputy Commissioners/ Gram Panchayats.

The details of the PPAs entered into will be sent to you by the Managing Directors of concerned ESCOMS. You may initiate action for violation of the Karnataka Land Revenue Act and Karnataka Land Reforms Act.
