## Preamble:

Government of Karnataka in the Budget 2021 has announced setting up of EV Charging Stations under PPP Model. Directions are already issued in this regard from the office of Chief Secretary, GoK vide letters cited under ref (1) & (2) for identifying, earmarking and sharing the locations with BESCOM. As per letter ref (3) Action Plan submitted by BESCOM has been approved and directions are issued to take necessary actions to set-up 1190 EV Charging Stations in 31 districts under PPP Model. Further as per BESCOM action plan vide clause 5, a DISCOM level EV Cell i.e. "CESC EV Cell" shall be created along with Nodal officers of Executive Engineer & above rank for each DISCOM and District level officer of Executive Engineer Rank for each District within the DISCOM.

# Roles and Responsibilities:

#### DISCOM EV Cells shall

- 1. Shall assist State Nodal Agency (SNA) in monitoring implementation of the project in their respective zones defined by SNA.
- 2. Obtain necessary approvals from SNA for carrying out the implementation activities.
- 3. Assist SNA by identifying the locations for setting up EV Charging stations I the zones.

- 7. Recommend to SNA for termination of the contract as per the terms and conditions defined in the tender documents.
- 8. Issue operation acceptance certificates to the concessionaire duly adhering to the specifications defined in the tender documents.

## **District Level Officer shall**

- 1. Assist the DISCOM EV cell for smooth implementation of the project.
- 2. Coordinate with the officer appointed by the Government of Karnataka for carrying out the related activities such as
  - a. Identifying the locations for setting up EV Charging Stations.
  - b. Carrying out technical feasibility study of the locations.
- 3. Submit the feasibility reports to the DISCOM EV Cell for validation of the locations.
- 4. Consolidate and furnish the identified locations to the DISCOM EV Cell for including in the tender / Eol.
- 5. Monitor the implementation of the project in their respective jurisdiction. 6. Assist the selected bidder / concessionaire and the land owning agency for executing the contract agreements.
- 6. Recommend to DISCOM EV Cell for levying penalties to the concessionaire for any violations in the Service Level Agreements.
- 7. Recommend to DISCOM EV Cell for termination of the contract as per the terms and conditions defined in the tender documents.
- 8. Assist Concessionaire in availing power supply to the EV Charging Stations by coordinating with the concerned office of the respective DISCOMs. 10. Recommend to DISCOM EV Cell for issue of operational acceptance certificates to the concessionaire duly adhering to the specifications defined in the tender documents.
- 9. Assist in arranging the necessary documents / permits from the land owning agencies for executing the concession agreement.
