Anent to the above subject vide ref (1) it is stated that Chief Engineer(Ele), Transmission Zone, KPTCL, Mysore has requested to accord approval for availing line clear on 220kV Basthipura-Kushalnagar DC Line from 10:00AM to 14:00 Hrs on 26.02.2023 for a period of 04 hours to provide 220kv Jumps to 220kv Basthipura-Thammadahalli-Kushalanagar Double LILO in order to make LILO arrangement. and in order to commission the new receiving station, 220kv Basthipura-Thammadahalli-Kushalanagar DC line need to be commissioned and same is scheduled on 26.02.2023.

In continuation it is stated that In order to arrange uninterrupted power supply to EHT, Urban, Industrial and Semi-Urban feeders during line clear period of 220kv Basthipura-Kushalnagar DC Line following arrangement is need to be made.

- The partial load upto 25MW of 220kv Kushalnagar will be shifted to 66kv Ramanathapura line which will be fed from 220kv Kadavinakote R/s in Holenarasipur Taluk Hassan District.
- > Around 70MW of load will be shifted to 220kv Hootagalli R/s.
- > Presently there is huge load demand from IP sets and hence these load cannot be met by any arrangement.
- As Line clear period requested is only 04 Hours i.e from 10:00AM to 14:00 Hrs on 26.02.2023, it is requested to arrange Power supply to IP feeder before 10:00AM or after 2:00PM on 26.02.2023 and to shut down the IP feeders emanating from all 66/11kv Sub-Station coming on 220kv Hootagalli R/s and 220kv Kushalnagar R/s during Line Clear Period.

Further, it it is stated that Superintending Engineer (Elec.), O&M Circle, CESC, Mysore and O&M Chamarajnagar- Kodagu has accorded to concurrence for availing line clear for the above said work and you are also recommended for the line clear.
