Anent to the above subject vide ref (1) it is stated that Chief Engineer(Ele), Transmission Zone, KPTCL, Mysore has requested vide reference (1) to arrange concurrence for availing Line clear on 66kv Hootagalli-Hunsur-Hosur Gate line and 66/11kV Hosur Gate S/s on 16.01.2023, 18.01.2023, 20.01.2023, 22.01.2023 and 25.01.2023 alternatively for 05 days from 08:00AM to 18:00Hours for Establishing 2x100 MVA, 220/66/11kV R/s at Hunsur (Thammadahalli).

In continuation it is stated that during LC period it is proposed to construct 66kv SC Transmission line on DC towers from Proposed 220/66kV Thammadahalli R/s to existing 66/11kV Hosur Gate S/s along with construction of 02 No of 66kv Terminal Bay at Hosur Gate S/s for a distance of 11.178Kms and also proposed to string 66kv Thammadahalli-Hosur gate Line on the existing 66kv Hosur Gate DC towers for a distance of 3.209Kms from Location no 37 to 51(Hosur Gate S/s). Hence line clear is required for stringing of 3.209kms of Line on the existing tower.
