Sir,

Sub: Approval for availing line Clear of 220KV Bastipura-Hootagally D/C Line for shifting of 66kV lines and heightening of 220kV D/C EHT lines at 3rd phase, Industrial Area, Koorgalli Village limits to increase between 220kV and 66kV Lines, Under "Self Execution" by KIADB, Mysuru- Line Clear of 220kv Bastipura-Hootagally D/Cline.

Anent to the above subject vide ref (1) it is stated that Chief Engineer(Ele), Transmission Zone, KPTCL, Mysore has requested to accord approval for availing line Clear of 220KV Bastipura-Hootagally D/C Line from 9:00Hrs to 18:00Hrs of 27.01.2024, and 28.01.2024 for 2 days, the subject work in favour of M/s KIADB, Mysuru. At present, 66kV Hootagally-Yelawala S/C line, 66kV Hootagally – Bannikuppe S/C line and 66kV Hootagally- BARC D/C lines are passing below the existing 220kV Bastipura- Hootagally D/C line and the clearance between these lines is not as per CEA Regulations-2023. In continuation in the above letter it is mentioned the details work carried out and alternate arrangement of power supply during LC period.

Further, it is stated that Superintending Engineer (Elec.), O&M Circle, CESC, Mysore has accorded concurrence for availing line clear on 27.01.2024 and 28.01.2024 for the above said work and you are also recommended for the line clear.

In view of the above, I am hereby directed to accord approval to avail line clear on 220KV Bastipura-Hootagally D/C Line from 9:00Hrs to 18:00Hrs of 27.01.2024, and 28.01.2024 for 2 days. Further, instruct the concerned Executive Engineer (Ele) O & M Division to carry out feeder maintenance during LC period and to issue paper notification regarding line clear. In continuation if 220kV Bastipura-Kadakola DC lines, Hootagally –Vajmangala & Vajmangala-TK Halli lines are overloaded the power supply to IP feeders will be curtailed and any line fault occurs power supply to all downstream sub-stations coming under above 220kV lines will be interrupted.
