Anent to the above subject, vide your letter under reference(1), it is stated that Chief Engineer(Ele), Transmission Zone, KPTCL, Mysore has requested to arrange concurrence for availing Line clear of 66KV Devnur (Nanjangudu) & Suttur Substations along with associated lines for the below mentioned works on 15.11.2021, 24.11.2021 and on 30.11.2021 between 07:00Hrs to 18:00Hrs.

- 1. 66kv Devanur (Nanjangudu) to Hemmaragala S/c Line in Mysore District:
  - Since, 66kv Kadakola-Devanur (Nanjangudu) S/c Line from EHT M/s Kayathi Steel upto LILO point of Devanur (Nanjangud) S/s is already under line clear from 24.10.2021 and almost 35 towers are erected in this bit and in order to complete the project, 04 Nos of Intermediate towers are to be erected and 02 Number of Towers to be replaced from LILO point to Devanur S/s Limits along with replacement of Coyote conductor by Drake by availing LC on 66kV Devenuru to Hemmaragala line as the same is running on common Tower
- 2. 66/11kv Devanur(Nanjangudu) S/S and Suttur S/s: Line Clear on 15.11.2021, 24.11.2021 and on 30.11.2021
