Anent to the above subject, vide your letter under reference(1), it is stated that Chief Engineer(Ele), Transmission Zone, KPTCL, Mysore has requested to arrange concurrence for availing Line clear for replacement of existing tower for the work of increasing the vertical clearance of proposed 66kV line from Garudana Ukkada-Metagalli S/C line with "ACSR COYOTE" conductor crossing the proposed NH-275(Bangalore-Mysore) Road at Ch.
