Anent to the above subject vide ref (1) it is stated that Chief Engineer(Ele), Transmission Zone, KPTCL, Mysore has requested to arrange concurrence for availing Line on 66kv Hunsur-Hanagodu Line from 17.12.2022 to 19.12.2022 from 09:00AM to 18:00 Hours and at present this line is under idle condition at Hunsur station end.

In continuation it is stated that for construction of proposed 66kV LILO line from the existing 66kV Hunsur-Hanagodu Line to the proposed 220/66/11kV receiving-Station at Tammadahalli for a distance of 1.490Kms in Hunsur Taluk, Mysuru District, it is required to erect one number of intermediate tower to the existing 66kV Hunsur-Hanagodu Line, and one number of existing suspension type Tower to be replaced by Anchor Tower.

Further it is mentioned that by considering the above work as essential & as no power supply will be interrupted during line clear period youself are also recommended for line clear and to maintain Un-interrupted Power Supply the following are the arrangements:
