Anent to the above subject vide ref (1) it is stated that Chief Engineer(Ele), Transmission Zone, KPTCL, Mysore has requested to arrange concurrence for availing Line on 66 KV Kushalanagar-Madikeri Line on 11.12.2022 to carry out the balance work of Construction 66KV SC line on DC towers from 66/11kV Madikeri Substation to 66/33/11KV Virajpete Substation for a distance of 37.38kms in Coorg Dist along with Construction of one number of 66KV Terminal bay at existing 66/11KV Madikeri substation in Madikeri taluk, Kodagu Dist and Construction of one number of 66KV Terminal bay at existing 66/11KV Virajpete substation in Virajpete taluk, Kodagu Dist on partial turnkey basis including supply of all matching materials /Equipments (Excluding KPTCL supplied materials) and erection (Including Civil works) of all materials/ Equipments, Testing and Commissioning.

In continuation it is stated that for the erection of the MD+6, 110 KV M/C Tower along with stringing of Coyote conductor for 2 Spans for restoring 66 kV power supply to the existing 66/11 Kv Sub Station Madikeri, the 66 KV Kushalanagar- Madikeri Line shutdown is necessarily required for one (01) day & 3<sup>rd</sup> Quarterly maintenance work at 66/11 KV sub station Madikeri is also scheduled on 11.12.2022 and by considering the above work as essential you are also recommended for line clear.

In view of the above, I am hereby directed to accord approval to avail line clear on 66 KV Kushalanagar-Madikeri Line on 11.12.2022 from 6:00 am to 6:00 pm and to instruct the concerned Executive Engineer (Ele) O & M Divisions to issue paper notification regarding line clear, to maintain uninterrupted power supply to covid hospitals and also to coordinate with KPTCL officers during line clear period.
