Sub: Approval for availing Line Clear for 66kV Lines to carry out the balance work of construction of 220kv DC Line from 220kv Kadakola R/s to 220kv Vajamangala R/s for a distance of 14.488Kms and construction of 2 Nos of 220kv TB's at Kadakola R/s in Mysore Taluk and district along with dismantling of Equipments /materials on partial turnkey basis..-Reg.

Anent to the above subject vide ref (1) it is stated that Chief Engineer(Ele), Transmission Zone, KPTCL, Mysore has requested to arrange concurrence for availing Line on 66kv Vajamangala-Hebbani Line from 28.10.2022 to 01.11.2022 continuously for 05 days to erect 01 No. of 220kV MC Tower underneath the existing 66kv Vajamangala-Hebbani Line for crossing arrangement for proposed 220kv Kadakola-Vajamangala Line at location No 02.

In continuation it is also stated Superintending Engineer (Elec.), O&M Circle, CESC, Mysore has accorded Concurrence for availing line clear for the above said work and you are also recommended for line clear and stated that in order to take up the above work Line clear of following 66kv Transmission line and 11kv Feeders are required.

Further it is stated that during line clear period the following arrangements shall be made to maintain Un-interrupted Power Supply

- Power Supply for the existing **66kV EHT Nanjanpura LIS** will be interrupted for one hour for opening the Jumps near 220kv Vajamanagala end and the load of the 66kV EHT Nanjanpura LIS will be fed from 220kV Hebbani R/s.
- 03 phase Power supply for the IP feeder shall be given during night hours.

In view of the above, I am hereby directed to accord approval to avail line clear on 66kv Vajamangala-Hebbani Line from 08:00AM of 28.10.2022 upto 17:00 Hours of 01.11.2022 continuously for 05 days to erect one number of intermediate 220kV MC tower and also for the above mentioned 11kv Feeders emanating from 220/66kv Vajamangala R/s on the above said dates and to instruct the concerned Executive Engineer (Ele) O & M Divisions to issue paper notification regarding line clear, to maintain uninterrupted power supply to covid hospitals and also to coordinate with KPTCL officers during line clear period.
