Anent to the above subject vide ref (1) it is stated that Chief Engineer(Ele), Transmission Zone, KPTCL, Mysore has requested to arrange concurrence for availing line clear for construction of 66 KV M/C line from proposed 220 KV Nagamangala Substation Up to Koppa tapping point (AP-20) for a distance of 12.55 Km & conversion of existing 66 KV Koppa S/C line to D/C line from Koppa tapping point (AP-20) to 66 KV Koppa sub-station for a distance of 14.35 Km associated with Dismantling works and the power supply to the following sub-station will be affected.
