Sub: Approval for availing Line clear for availing Line Clear of 66/11kV Chandravadi, Hura and Hullahalli S/s for providing radial Connectivity to 66kV Hura Sub-staion from 66kV Chandravadi (Nallithalapura) S/s in Nanjangud Taluk, Mysuru district

Anent to the above subject vide ref (1) it is stated that Chief Engineer(Ele), Transmission Zone, KPTCL, Mysore has requested to arrange concurrence for availing Line clear on 66/11kV Chandravadi, Hura and Hullahalli S/s on 30.12.2022 from 11:00 Hrs to 15:00Hrs for a period of 4 hours.

In continuation it is stated that there is no alternative 66kv source for 66/11kV Chandravadi, Hura and Hullahalli S/s during Line clear period, the Power Supply to 66/11kV Chandravadi, Hura and Hullahalli S/s will be interrupted for 04 hours.

Further, it is also mentioned that Superintending Engineer (Elec.), O&M Circle, CESC, Mysore has recommended to accord concurrence for availing line clear for the above said work on 05.01.2023 from 11:00 hrs to 15:00 hrs 66/11kV Hura S/s and 11:00 hrs to 13:00 hrs 66/11 kv Chandravadi, Hullahalli and Doora S/s and you are also recommended for the above line clear.

In view of the above, approval is accorded to avail line clear of 66/11kV Chandravadi ,Hullahalli & Doora S/s on 07.01.2023 from 11:00Hrs to 13:00Hrs for a period of 02 hours and 66/11kv Hura Station from 11:00 Hrs to 15:00 Hrs for a period of 04 hours and to instruct the concerned Executive Engineer (Ele) O & M Divisions to issue paper notification regarding line clear, to maintain uninterrupted power supply to covid hospitals and also to coordinate with KPTCL officers during line clear period.
