Preamble:

M/s R.K. Associates, Bengaluru has been awarded the work of providing electrical infrastructure by extending HT/LT line and erection of 25KVA DTCs for Ganga Kalyana & Water Supply installations on Total Turnkey basis under Unit Rate Contract in Madduru-2 Sub Division for ₹ 1.00 Crore. A total of 51 works have been awarded so far for ₹ 99.42 Lakhs, the agency has completed 49 works and the DWA period has expired on 04-01-2021 after one time extension from 23-05-2020. As many applications are expected to be registered in 2020-21 and inviting & finalizing fresh tenders may take time, Chief Engineer(Elec), O & M Zone, Mysuru has recommended to extend the DWA period for further six months with additional 25% DWA amount, vide the reference letter(2). GK/WS works are GoK sponsored works, in the interest of rural public for providing water for drinking and irrigation purpose for Gangakalyana beneficiaries, the works are to be done on priority basis. Hence I am here by directed to issue the following order.

Order:

Approval is hereby accorded to extend the DWA period along with 25% (₹ 25 Lakhs) additional amount over DWA amount, for the work of Providing electrical infrastructure by extending HT/LT line and erection of 25KVA DTCs for Ganga Kalyana & Water Supply works on Total Turnkey basis under Unit Rate Contract in Madduru-2 Sub Division with same rate, same terms and conditions of DWA vide reference (1) and its amendments if any, up to 28-02-2021. Bank Guarantee shall be extended up to 31-05-2021.
