Scope of Work :

1. Contractor shall supply the required quantity of polyolefin heat shrinkable tube insulation covered Rabbit ACSR conductor and other required materials as per the specification and execute the work as per the prepared estimate/Field requirement.
2. The released Rabbit and Weasel ACSR conductor and all other released scrap materials shall be returned to the concerned CESC O&M Divisional Stores by the contractor duly following the Corporate norms.
3. The agency shall arrange to restore the power supply to the consumers connected to the line after completion of the work.
4. The transaction of the released materials shall be done through the concerned divisional stores under the supervision of the area engineers as per prevailing norms.
5. The Superintending Engineer (Ele.), O&M Circle, CESC shall allocate the O&M division wise quantum of work to be carried out limiting the amount to Rs.800.00 lakhs.
6. The concerned Executive Engineer (Ele.), O&M Divisions, CESC shall arrange for issuing work award according to estimates furnished.

1. Description of the Work: For supplying of materials for Providing LT polyolefin heat shrinkable tube insulation covered Rabbit ACSR Conductor in place of the existing bare Rabbit/ Weasel conductor duly releasing the same restringing the insulated conductor on total turnkey Basis in O&M Circle , Hassan, CESC jurisdiction.

2. Price Schedules:

Quoted price of individual materials required for the scope of work is as in Annexure – A.

3. Work awarding officer:

The Superintending Engineer (Ele.), O&M Circle, CESC shall allocate the O&M division wise quantum of work to be carried out.

The work awarding officer is the Executive Engineer (Ele.), O&M Division, CESC on unit rate contract and will issue the award of work depending upon the requirements as per company norms.

4. Completion period:

The work shall be completed in all respect within the **18 months from the date of DWA**. However, early completion of works is preferred.

5. Prices:

The prices are firm and no price variation will be allowed as per clause (12) of ITB of bid document.

6. Penalty:

Penalty for delay will be levied as per Clause 13.0 of SCC of bid document.

7. Taxes and Duties:

The amount of award is inclusive of all applicable Taxes/GST/duties or levies that are applicable in respect of transaction between the firm and CESC. If there is any concession/reduction in the taxes & duties due to change in the policy, same shall be availed and passed on to CESC. If there is any increase in taxes during contract period, the same shall be borne by CESC. No claim for increase in any variation of statutory taxes and duties or levies or due to introduction of new tax shall be entertained during the extended period of contract attributable to the bidder.

8. Completeness:

All the necessary materials that are required if necessary for the work even though that have not been mentioned in the award but are necessary for successful completion of work is deemed to be included in the award and the contractor shall supply those materials and complete the work. Rates at prevailing SR plus tender premium shall be paid for Non-DWA items. The use of the same in works shall be certified by the jurisdictional Section, Sub Division and Division Officer.

9. Payment:

The terms of Payments shall be as per Clause 8.0 of SCC of bid document ;

- a. Payment of 50% of the material value + 100% taxes and duties with freight and insurance will be made upon supply of material and 40% of the material value along with 90% labour charges for erection+100% taxes & duties on labour charges will be made after successful completion of works in the subdivision/Section.
Balance ten percent (10%) of the total cost of each work award will be retained with CESC towards fulfillment of work performance guarantee period of Two year and will be released on completion of the guarantee period for the works entrusted to the turnkey contractor on certification by the concerned officers of CESC
- b. The Contractor shall submit the
 - a) For supply Portion: i) Bills in quadruplicate (4 copies), ii) Acceptance/test report of material, and iii) Dispatch instructions .
 - b) Labour Portion:
 - i) The completion certificate issued by the concerned AEE/section officer, ii) the measurement book with entries, to the Engineer-in-charge in prescribed form approved by the Engineer-in-charge, only when all the works pertaining to each sub-division/section is completed in all respects. Payment will be made against measurements as per actual at the approved unit prices of contract. The payments to Contractor are subject to recoveries, which are due from the Contractor.
- c. The measurements shall be jointly taken by the authorized representatives of the Engineer-in-charge and the Contractor. The representative of the Engineer-in-charge will give a week's notice to the Contractor of his intention to record the measurement and if the Contractors' representative fails to join the Engineer's representative the latter may proceed with the measurements by himself and the Contractor shall have to accept these measurements as correct and binding on him.
On the basis of these joint measurements, payment will be made to the Contractor by the Engineer-in-charge according to the procedure prevalent in CESC.
Payment will be made at the accepted rates for all works done according to the specifications and measurements.
- d. All materials and work for which payment is made in part or full shall become the sole property of CESC, but this provision shall not relieve the Contractor of

- his responsibility for the care and protection of the materials and works at his own cost and his liability to make good the damage if any unless and until the whole work is deemed to have been completed and handed over to CESC, in accordance with the terms and conditions of the contract.
- e. The periodical measurements and payments will not entitle the Contractor to any claim that the works for which payment has been made are accepted as complete in accordance with the specifications, drawings or other contract documents and in no way will curtail the right of the Engineer-in-charge to subsequently direct the removal of imperfect work or pay at a lower reduced rate, or to re-measure the works.
 - f. The Contractor shall not be entitled to claim any interest upon any arrears or upon any balance, which may be found due to him at any time.
10. Notwithstanding anything contained to the contrary in the Bid documents, storage insurance for materials stored at the site by the contractor shall be to the account of the Contractor alone and no amount whatsoever is payable by the CESC, Mysore.
11. **Jurisdiction of contract:**

12. The materials other than polyolefin cover shall be procured from CESC approved vendors only. However insulation provided shall be as per specification given by CESC. Any proposal for procurement of materials from other than the approved vendors, 'vendor approval' shall be obtained from the CESC prior to supply of such bought out items. The CESC reserves the right to choose vendors for approval.
13. **Approval for Drawings:**
Necessary approvals for the drawings of the materials to be supplied to the works are to be obtained in advance from the undersigned.
14. **Commissioning of completed work:**
Approval from Electrical Inspectorate, Govt. of Karnataka/Railway Crossings shall be obtained by the contractor before commissioning and handing over of completed work to the concerned Executive Engineer (Ele.), O&M Division, CESC. The statutory charges for the same shall be reimbursed by CESC, Mysuru on submission of suitable documents.
15. **Guarantee:**
The materials supplied and the work executed shall be guaranteed for a period of 24 months as per clause 15.0 of GCC of bid document.
16. **Performance Guarantee:**
The firm has furnished a Bank Guarantee for ₹27,00,000/- towards performance guarantee. The Bank Guarantee is valid up to 05-11-2024. For a period of **24 months** from the date of issue of the completion certificate, the Contractor shall be liable for the works or any portion thereof, found to be defective from causes arising from faulty materials or workmanship or other causes for which, in the judgment of the Engineer, the Contractor will be held responsible, the contractor shall make good any damages arising there from, notwithstanding the fact that the final certificate, may have been issued and the security deposit to be refunded.


