M/s Maxwell Electrical Engineers, Bengaluru has been awarded the work of providing electrical infrastructure by extending HT/LT line and erection of 25KVA DTCs for Ganga Kalyana & Water Supply installations on Total Turnkey basis under Unit Rate Contract in Dudda Sub Division for ₹2.5 Crs. A total of 140 no. of works have been awarded so far for ₹1.94 Cr and the agency has completed 132 works and DWA period has expired on 20-02-2021 after extension from 20-02-2020. As still around ₹0.56 Crs of DWA amount is pending to be awarded, SEE, Hassan Circle has recommended to extend the contract period along with 25% enhancement in DWA amount.
