Preamble:

The work of carrying out for replacement of existing LT overhead lines by LT Aerial bunched cable on total turnkey basis in O&M Circle Chamarajanagar-Kodagu, CESC jurisdiction as per given specification of CESC was awarded to M/s A N Royal Engineering India Pvt Ltd., Bengaluru vide DWA cited under ref(1) for Rs.135.00 Lakhs. The SEE, O&M Circle, CESC, Chamarajanagar-Kodagu vide their letter no cited under ref.(2) requested that, ₹ 135.00 lakhs amount of the work was already completed and still many works are to be carried out on emergency basis in accident prone areas. The agency also submitted his consent to take up the works for the additional quantity of 25% of the DWA amount. Hence they requested to extend the 25% of the DWA amount. 
