M/s Shree Prema Industries & Electricals, Mysuru has been awarded the work of providing electrical infrastructure by extending HT/LT line and erection of 25KVA DTCs for Ganga Kalyana & Water Supply installations on Total Turnkey basis under Unit Rate Contract in Malavalli-2 Sub Division for ₹3.00 Crores. A total of 101 Nos. works have been awarded so far for ₹189.51 Lakhs, the agency has completed 52 Nos. of works and the DWA period has expired on 20-02-2020. As many applications are expected to be registered in 2020-21 and still ₹110.49 Lakhs amount is pending to be awarded, Chief Engineer(Elec), O & M Zone, Mysuru has recommended to extend the DWA period for further six months, vide the reference letter(2).
