Sub: Amendment to KPTCL Manual of Delegation of Powers -2018 – Sanction of Injury Leave - Reg.

READ:

1. Corporate Office Order No: KPTCL/B25/23720/2011-12 dated 21.03.2018.
2. Resolution No: 121/17 of the 121st Meeting of the Board of Directors of KPTCL held on 09.09.2020.

PREAMBLE:

The Revision of Manual of Delegation of Powers was approved in the 109th Meeting of the Board of Directors of KPTCL held on 19.02.2018. Accordingly, in order No.KPTCL/B25/23720/2011-12 dated 21.03.2018, the KPTCL Manual of Delegation of Powers – 2018 was issued, which has come into force w.e.f. 01.04.2018.

In **Sl. No.6.12** of the KPTCL Manual of Delegation of Powers-2018, the Chief Engineer, Electy., has been delegated full powers for sanction Injury Leave upto 6 months with or without extra cost.

Earlier, the Superintending Engineers (Elec.) and Executive Engineers (Elec.). were also authorised to sanction Injury Leave.

It was noted that, the workmen who are injured while on duty have been subjected to hardship due to delay in sanctioning of Injury Leave. The matter was deliberated in the 121st Meeting of the Board of Directors of KPTCL held on 09.09.2020. Since the maintenance men at field level are prone to injuries while on duty, to facilitate sanctioning of injury leave, it was decided to restore the arrangement as existing earlier.

Hence the following Order.


