CIRCULAR

Sub: Arranging power supply to the building under clause 3.1.3(A) of KERC (Recover of Expenditure for Supply of Electricity) (Ninth Amendment) Regulations, 2017.

Preamble:

In the ninth amendment of KERC (Recovery of Expenditure for Supply of Electricity) Regulations -2017, the new clause 3.1.3(A) has been introduced with effect from 01.02.2018. As per the new clause 3.1.3(A) "in case of new buildings, where the requisition load is 25KW or more but less than 35kW or built-up area of the building exceeds 500SQM but less than 800SQM, the applicant shall provide the required space at free of cost in his premises for the erection of distribution line & transformers and associated equipment at its cost by the licensee."

While arranging Power Supply under clause 3.1.3(A), in some of the cases, Where there is no suitable space (Open to Sky) is available in the applicant premises to provide free of cost to the CESC, in such cases, the applicants are seeking the approval to provide the Dry type distribution transformers under self-execution.

In the prevailing clause 3.1.2 of KERC (Recover of Expenditure for Supply of Electricity) Regulations-2017, it is stated that "Provided the Applicant opts for executing the work of extension of electric line/plant on his own as per the estimate, standard drawings and specifications of the licensee, the same shall be granted. In such cases, the Applicant shall pay supervision charges at 10% of the estimated cost of the work excluding employees cost subject to a maximum of Rs. 15 Lakhs".

Further, to have uniformity across the company, BESCOM has issued a circular vide reference no. 1, the applicant shall provide the Dry-type distribution transformers under self-execution duly obtaining CEIG approval.

The Chief Engineer (Ele), O&M zone, CESC, Mysuru and Superintending Engineer (Ele), O&M circle, Mysuru have requested the Corporate Office for issuing of similar circular in CESC also to follow the uniform procedure in all O&M divisions in arranging power supply to new build...

For arranging power supply to the new buildings, where the requisitioned load is 25KW or more but less than 35KW or built-up area of the building exceeds 500 SQM but is less than 800 SQM. and where there is no suitable space (Open to Sky) is available in the applicant premises to provide at free of cost to CESC and if consumer opts for erection of dry type distribution transformers under self-execution, in such cases the following guidelines shall be followed;

1. The Applicant shall obtain the drawing approvals from CEIG, GOK, and shall be submitted to the CESC.

The above procedure shall be followed strictly with immediate effect until further orders.
