## PREAMBLE:

In KPTCL Order No: KPTCL/B16/23040/2011-12, dated 18.08.2012, amendments were issued to Chapter-VI of the KEB Recruitment & Promotion Regulations at provisions of Sl. No. 12 A (i) and 13 A (ii) for Appointment by Transfer of in-service employees working in lower cadres possessing and acquiring higher qualification such as BE/AMIE, to technical cadre posts of Junior Engineer (Elec.)/Store Keeper Gr.II and Junior Engineer (Civil).

The Board in its 92<sup>nd</sup> Meeting held on 18.03.2015 had accorded its approval to withdraw with immediate effect all the orders issued from time to time as regards Appointment by Transfer to technical cadre posts and further, authorized the MD, KPTCL to approve the pending instances of the claims of employees seeking appointment of transfer from the cadre of Junior Engineer to Assistant Engineer after examining the same in accordance with the rules and Regulations which were prevailing earlier to the issue of necessary amendments.

Accordingly, an Order was issued vide No: KPTCL/B16/7208/2014-15 dated 03.06.2015, withdrawing all orders

issued from time to time as regards Appointment by Transfer. Necessary deletions were made to the relevant provisions for method of recruitment and minimum qualification prescribed for Appointment by Transfer to the post of Assistant Engineer and Junior Engineer in Notification No: KPTCL/B16/7208/2014-15 dated 11.06.2015.

On the request of some of the Junior Engineers (Elec.) to consider them for appointment by transfer to the post of Assistant Engineer (Elec.), approval was accorded in the 109<sup>th</sup> Meeting of Board of Directors of KPTCL held on 19.02.2018, to consider Appointment by Transfer from the post of JE (Elec.) to the post of AE (Elec.) of the following subject to fulfilling the condition of completion of 3 years of qualifying service and possessing BE Degree as a one-time measure:

- i. 39 Nos. of Junior Engineers completed their BE degree prior to the withdrawal of scheme of appointment by transfer but not completed the qualifying service of 3 years well within the withdrawal of the scheme of appointment by transfer i.e., 18.03.2015.
- ii. 63 Nos. of Junior Engineers completed qualifying service of 3 years prior to the withdrawal of scheme of appointment by transfer and who had obtained prior permission for pursuing BE degree but completed their BE degree after withdrawal of the scheme of appointment by transfer i.e., 18.03.2015.

Accordingly, an order was issued on 26.03.2018 on the above lines.

Further, some of the employees working in the lower cadres i.e., Operator/Overseer/Meter Reader/Asst. Store Keepers who had obtained prior permission for pursuing BE/AMIE qualification before the withdrawal of scheme of appointment by transfer i.e., 18.03.2015, had requested in their representation dated 04.07.2018 to consider them for appointment by transfer to the post of Junior Engineer (Elec.) quoting on similar lines of order dated 26.03.2018.

In view of this, the said subject was discussed in the 122<sup>nd</sup> meeting of the Board of Directors of KPTCL held on 30.11.2020 and the Board accorded its approval to consider the Appointment by Transfer of the BE/AMIE qualified other cadre employees to the post of Junior Engineer (Elec.)/Store Keeper Gr.II, subject to the condition of obtaining notarized affidavit from the applicant that he/she shall not claim similar benefit of appointment by transfer



from Junior Engineer to the cadre of Assistant Engineer and other terms and conditions.

Hence, the following Order:-

**ORDER NO: KPTCL/B16/7208/2014-15 (III), BENGALURU, DATED:**

KPTCL is pleased to accord approval subject to fulfillment of the following conditions, for the appointment by transfer from the other cadres to the post of Junior Engineer (Elec.)/Store Keeper Gr.II duly observing the relevant provisions of KEB Recruitment & Promotion Regulations existing prior to withdrawal of the said scheme: -

- i) Employees who have completed their BE/AMIE Qualification prior to the withdrawal of Scheme of Appointment by Transfer but not completed the qualifying service of Four (4) years well within the withdrawal of the scheme i.e., 18.03.2015.
- ii) Employees who have completed qualifying service of Four (4) years prior to the withdrawal of scheme of Appointment by Transfer and who had obtained prior permission prior to 18.03.2015 for pursuing BE/AMIE qualification, but completed their BE/AMIE Qualification after withdrawal of the scheme i.e., 18.03.2015.

The aforesaid appointment by Transfer from other cadres to the post of Junior Engineer (Elec.)/Store Keeper Gr.II shall be considered subject to the following conditions:

- i) After obtaining necessary notarized affidavit from the applicant that he/she shall not claim the similar benefit of Appointment by Transfer from Junior Engineer to the cadre of Assistant Engineer.
- ii) The Seniority will be fixed based on the date of joining in Junior Engineer cadre.

Further, the undersigned is authorized to approve the Appointment by Transfer as deemed appropriate under the circumstances on case to case basis.


