Preamble:

1. The Hon'ble KERC has notified the KERC (Fuel and Power Purchase Cost Adjustment) (First Amendment) Regulations 2023 on 23.02.2023 and published in the Karnataka Gazette on 24.02.2023.
2. Further, FPPCA for Feb-2023 has been claimed as per T.O order no. CESC/GM(Coml)/DGM(RA2)/AGMRA2/2022-23/CYS1889 Dtd:31.03.2023.
3. The FPPCA statement for the billing month May-2023 has been prepared as per the KERC (Fuel and Power Purchase Cost Adjustment) Regulations 2023 dtd: 23.02.2023.
4. The approved power purchase cost has been considered as per Hon'ble Commission Tariff order Dtd: 04.04.2022.
5. The source wise power purchased and Transmission charges of KPTCL for the month of March-2023 has been considered for computing FPPCA.
6. The sale for the month of March-2023(Provisional) has been considered.
7. The power purchase cost for the month of March-2023 is more than the approved power purchase cost by Rs. 124.415 Crs
8. The FPPCA of CESC for the billing month of May-2023 works out 166 paise/unit.

In accordance with the provisions of KERC Notification No.B/5/12/2807 Dtd: 23.02.2023, having recognized the variation in the Fuel and Power Purchase Cost in the month of March-2023, approval is hereby accorded to collect the Fuel and Power Purchase Cost Adjustment Charges (FPPCA) of **53 paise per unit** (Provisionally) of sale in all the energy bills to be issued to the consumers from **01.05.2023** in respect of all categories of consumers except BJ/KJ and IP sets of 10HP and below, subject to adjustment of the same in the final computation and final order to be issued in this regard. In respect of BJ/KJ and IP sets of 10HP and below, **166 paise per unit** to be billed and recovered from **01.05.2023**, subject to adjustment of the same in the final computation and final order to be issued in this regard.
