Preamble:

Detailed Work Award was placed for sale of Three Phase, Four wire, 5A, class-0.5s, CT operated Static AC Trivector Energy Meters through retail out lets on Rate Contract basis in the jurisdiction of CESC on M/s Landis+Gyr Limited, Kolkata, vide DWA no. mentioned in reference(1). Further, due to implementation of GST rate correction OM also issued vide OM no cited under ref.(2). The currency of the DWA is three years which was expired on 03-07-2020. Meanwhile CEA notification has been published in gazette stating that, Smart meter with payment feature are to be procured for all new consumers and for replacement of existing static meters. Hence for processing of new tender for CT operated Static AC Trivector Energy Meters was withheld as for the new Smart meters tender PQR, Technical Specifications are required which are awaited from CPC, BESCO, Bengaluru duly making letter correspondences in this regard. And hence to avoid hindrance to consumers of CESC in purchasing of CT operated Static AC Trivector Energy Meters and for smooth going, it is essential to extend the contract period of the present DWA. M/s Landis+Gyr Limited, Kolkata have also requested to extend the currency of the contract period duly agreeing the present DWA terms & conditions vide ltr no cited under ref (3). The


proposal was approved for extension of contract period of DWA for three months vide ref (4).Hence this order.
